

## Technical Information Granit Spray



Decorating spray for identical granit-look. DUPLI-COLOR Granit is suitable for interior and exterior use. For weather-resistance the assortment includes a special clear coat, art.no. 659188.

DUPLI-COLOR Granit is applicable on every surface; wood, metal, glass, ceramics, porcelain, paper, cardboard, stone, plastics and even on expanded polystyrene.

For optimal adhesion to the ground a suitable primer is necessary.

## **Quality and properties**

- Special, aerosol-resistant, waterbased synthetic quality
- Matt coating with glossy clear lacquer is possible
- Excellent adhesion
- · Light-proof, non-yellowing
- No unpleasant odour

#### Physical and chemical data

- Basis: plastics quality, water-based
- Colour: diverse

#### **Environment and labelling**

Environmentally sound: European Aerosols is committed to apply formulations without restricted or critical ingredients and to achieve best possible performance. The caps and packagings are made of recyclable material.

Disposal: Only the completely emptied cans should be put into the recycling skip or appropriate container for reclaimable refuse. Cans which are not empty should be disposed off as "special refuse"

Marking/Labelling: All products made by European Aerosols comply with the actual labelling regulations according to Preparation Guideline 1999/45/EG. All aerosols correspond to TRGS 200 and TRG 300 as well as to aerosol guideline 75/324/EWG in the actually valid version.

#### Using instructions

The most DUPLI-COLOR spray paints have a so-called no-spray ring or a tamper-proof cap. This is to avoid unauthorized use. Please see the corresponding advises on the cap or on the label.

Before use, carefully read and observe the warning texts on the label!

### Application

#### Preparation of the ground:

- When applying light Granit Style colours on dark surfaces pre-coat a light primer, for example DUPLI-COLOR Universal Primer art.no. 325021
- Plastic objects are recommended to be primed with DUPLI-COLOR Plastic Primer.
- If necessary slightly sand surface. Remove the dust from smoothing.
- The surface must be clean, absolutely free of grease and dry.
- Cover areas not to be painted.

# Lacquering:

- Shake the can for 3 minutes.
- Test spray at an invisible spot.
- Spraying distance approx. 30 cm several thin coats at 2 minute intervals.
- To seal and protect the granite structure it is necessary to coat after drying (24 hrs.) with DUPLI-COLOR Granit Style clear lacquer or one of the below mentioned varnishes (especially at exterior use), e. g.: - with the quick-drying DUPLI-COLOR Cristal Spray, glossy or matt

  - with polystyrene-resistant DUPLI-COLOR Deco Matt clear lacquer

## Tips for spray painting

Protect the object and the surrounding area from spray mist. Temperature should range between +10°C and +25°C, max. air humidity 60 %.

Store in a dry place. Protect from direct sunlight and other sources of heat. Use only during dry weather, in places protected from the wind, and in
